

Continuing in Raintree Vacation Club's efforts to "Go Green", Members now have the option to opt in for Electronic Maintenance Fee statements instead of the paper statements that are mailed to the address on file.

Through the maintenance fee section after logging on to www.raintreevacationclub.com with their credentials, Members can opt in to these benefits by following the steps below:

1. Log into [raintreevacationclub.com](http://www.raintreevacationclub.com) using your personalized credentials and click on **"Pay Your Maintenance Fee"**
3. This will open your E-Statement
4. Mark the **"Send me e-statement notifications"** checkbox.



2. In the Options section, select **"E-Statement History"**:



Select the accounts for which you would like to receive E-statements.





NEW SCAMMER NOTICE

JANUARY 2018

We have recently become aware of several entities which have displayed numerous warning signs of fraudulent activity.

The first such entity is **Capital Acquisition Partners LLC**, which misappropriates both the RVC and Club Regina logos in order to convince Members that it can facilitate either the sale or rental of a Member's timeshare interest. After the Member pays a commission for a "successful" rental or purchase, they never receive the payment Capital Acquisition Partners promises.

Second, an individual purporting to be a Club Regina employee named **Ivan Garcia** who uses the fake email address **memberservicessales@membersservice.mx** has informed Members that he can cancel their memberships in exchange for thousands of dollars. Please be advised that this person is not a Club Regina employee, that this "offer" is fake, and that our member services email addresses all use the domain name raintreeclub.com and never memberservice.mx.

Third, an individual named **Liam Goldman** working for a company called **Advance Travel Inc.** has also contacted our Members with offers to rent their timeshare interests for what we believe to be wholly unrealistic prices in exchange for commission fees.

Lastly, please be wary of the companies **One to One Broker Dealer and International Sales Group NY LLC ("ISG")**. Similarly to Capital Acquisition Partners, One to One Broker misappropriates both the Raintree Resorts International and Club Regina logos in an attempt to convince Members that it can sell their timeshare interests for unrealistic prices. Once again, this requires a commission fee. As for ISG, this company has also reached out to Members claiming to represent buyers interested in purchasing their memberships. After looking into both companies, Raintree has found evidence that they are likely operated by the same individuals. A search of the address ISG provides in its correspondences not only shows that the address does not exist, but it also returns a result listing ISG at the same address that One to One Broker provides.

Please be aware that RVC has never been involved in leasing or marketing a Member's timeshare interest. Additionally, our member services email addresses all use the domain name raintreeclub.com.

When contacted by anyone offering to sell, rent or otherwise dispose of your timeshare, please be aware of the following warning signs:

- Unrealistic rental or sale prices for your timeshare
- Payment of upfront fees, such as taxes, transfer fees or prepaid maintenance fees, usually via wire transfer or cashier's check, which will be reimbursed at closing.
- Use of name and trademarks of Raintree Vacation Club ("RVC") on entity's website, emails or written materials (RVC does not endorse or is affiliated with any reseller or rental company)
- Request for your RVC username and password or for a limited power of attorney concerning your timeshare
- Claim that the entity/individual is affiliated/employed with Raintree Vacation Club

We strongly urge our Members to use extreme caution when contacted by individuals or companies who make claims that just seem too good to be true. Before doing anything, carefully research the individual or entity involved. Despite having professional-looking salesmen and websites, many of these companies are not legitimate.
