

# SANDCASTLE AT BIRCH BAY

## KNOW BEFORE YOU GO

In this installment in our series, we take a look at [Sandcastle at Birch Bay](#). We have included information on the resort, and some suggestions from the local staff.

### CHECK-IN/OUT

Check-in is at 4 p.m. Check-out is at 10 a.m. If you arrive before the room is ready, we can provide you with a key to use the pool area or you can relax on our observation deck or in our Clubroom on the fifth floor.

### CHARGES AT CHECK-OUT

No mandatory charges.

### PARKING

Parking at the Sandcastle is free. You will be issued a parking pass at check in. Campers, trailers, box trucks, motor homes and the like are not permitted to be parked at the resort. Please make other arrangements prior to your arrival. A list of local facilities for storing these types of vehicles and trailers during your stay can be obtained from the resort.

### RESTAURANT

There is a restaurant on the property that is not part of Sandcastle, and is independently owned and operated. Room service and charging to your room are not available.

### POOL & HOT TUB

The outdoor heated pool and hot tub are open daily from 8 a.m. - 10 p.m. Pool towels and pool toys can be checked out from and returned to the Guest Service Desk.

### BBQS

We have two Weber propane BBQs on the observation deck along with three picnic tables. BBQ cooking tools are available from the Guest Service Desk. The BBQs are available on a first come first served basis.

### EXERCISE FACILITIES

The fitness Center is available from 7 a.m. - 11 p.m. daily. Your room key will give you access to the fitness center, and towels are provided.

### YOUNG CHILDREN

Pack-n-plays and highchairs are available by request. While kid friendly, Sandcastle does not have babysitting services or a kid's club.

TWO BEDROOM: alarm clock, balcony/porch, bath towels, cable TV, DVD player, extra blanket/pillows, flat screen TV, fire place, hairdryer, iron, ironing board, phone, robes, safe, shampoo & conditioner, smoke/fire alarm, soap & lotion, towel & trash service, TV in all bedrooms, TV in the living room, washer/dryer, 8 sets of dinner dishes & utensils, blender, coffee pot, cutting board, dish soap & sponge, dishwasher & dishwasher tablets, four burner stove, frying pans, full size oven, full size refrigerator, glass and plastic drinkware, ice cube maker/ice cube trays, kitchen towels & pan holders, microwave, and Pyrex pans and dishes.

THREE BEDROOM: alarm clock, balcony/porch, bath towels, cable TV, DVD player, extra blanket/pillows, flat screen TV, fire place, hairdryer, iron, ironing board, phone, robes, safe, shampoo & conditioner, smoke/fire alarm, soap & lotion, towel & trash service, TV in two bedrooms, TV in the living room, washer/dryer, 10 sets of dinner dishes & utensils, blender, coffee pot, cutting board, dish soap & sponge, dishwasher & dishwasher tablets, four burner stove, frying pans, full size oven, full size refrigerator, glass and plastic drinkware, ice cube maker/ice cube trays, kitchen towels & pan holders, microwave, and Pyrex pans and dishes.



### HELPFUL INFORMATION

Air conditioning is in the common areas only. The units have ceiling fans, and box fans may be provided upon request.

All units either face the ocean or Mt. Baker:

- 1BD units are all mountain view
- 2BD units are ocean view, partial ocean view, or mountain view
- 3BD units are ocean or partial ocean view





## RESTAURANTS THE LOCALS AND STAFF LOVE

### **Dutch Mothers Family Restaurant**

Self-described as "simple - flavorful - abundant", Dutch Mothers will not only feed you really well, but also give you a taste of Holland with its charming atmosphere and friendly staff. ### **Packer's Oyster Bar**

Upscale dining in a casual atmosphere, located on the waterfront at Semiahmoo Resort. The glass front 180-degree view of the harbor is perfect for viewing the sunset. In addition to the oysters, we recommend the prawn cocktail or lamb burger. ### **BelleWood Acres**

Carve out an afternoon to spend at Bellewood Acres, home to one of the largest apple orchards in western Washington producing 20 different apple varieties. Here you can pick your own apples, take a tour, shop the 14,000 square foot farm market and gift shop, grab a bite at the Country Café & Bakery, and more. We recommend the farm-to-glass distillery [tour](#) (includes many samples and a private tasting) followed by a slice of pie at the bakery!

### **Point Whitehorn Marine Reserve**

Point Whitehorn Marine Reserve features 54 acres of forest, bluff and beach, with a 3/4 mile fully accessible trail to spectacular panoramic viewpoints of the Strait of Georgia and San Juan Islands. An easy trail of switchback path descends from the bluff to access a windswept cobble beach on the Puget Sound.

### **Semiahmoo Spit**

A sweeping gaze from this narrow coastal land ("spit") takes in two countries, two mountain ranges (North Shore Mountains and Mount Baker), and two bodies of water (Drayton Harbor and Semiahmoo Bay). Great for varied levels of hiking, biking, or kayaking. It is also one of the premier coastal birding sites in Washington where you can reliably see many species including eagles, falcon, heron, grebe, loon, ducks, and more.

## NEW SCAMMER NOTICE

We have become aware of an entity named **Equity Acquisition Services Inc.** ("EAS"), operated by **Neil Paulsen and Ricardo Rojas**, with possible involvement of another individual, **Giorgio Tarabusi**. EAS offers to either cancel timeshare memberships for upfront fees or purports to take ownership of an existing timeshare membership to allow the current owner to purchase a new timeshare membership from a different developer. In some instances, this entity has asked potential victims for a limited power of attorney and the user name and password to access the victim's Raintree account. Unbeknownst to the current owner, EAS never takes ownership of the timeshare membership at all, thereby causing the current owner to be potentially in breach of the terms of his/her timeshare membership and possibly incurring further legal liability.

We have also become aware of an entity named **Expeditions Travel Group** ("ETG") which has contacted various Raintree Vacation Club members with offers to sell or rent their timeshare interests for what we believe to be wholly unrealistic sale/rental prices. If agreeable, the owners enter into an agreement with another entity named **Dogwood Title** and are later asked to send several thousand dollars to the Mexican government for taxes. If the owners refuse, they are threatened with legal action for breach of contract. Alternatively, ETG also offers to rent out a timeshare owner's weeks. Once a rental agreement has been entered into, ETG then demands all maintenance fees for the weeks to be rented be prepaid to it. Owners who refuse are again threatened with a lawsuit for breach of contract. Unfortunately, once either the purported real estate taxes or maintenance fees are paid, ETG ceases all communications and never carries through on its promises.

When contacted by anyone offering to sell, rent or otherwise dispose of your timeshare, please be aware of the following warning signs:

- **Unrealistic rental or sale prices for your timeshare**
- **Payment of upfront fees, such as taxes, transfer fees or prepaid maintenance fees, usually via wire transfer or cashier's check, which will be reimbursed at closing.**
- **Use of name and trademarks of Raintree Vacation Club ("RVC") on entity's website, emails or written materials (RVC does not endorse or is affiliated with any reseller or rental company)**
- **Request for your RVC username and password or for a limited power of attorney concerning your timeshare**
- **Claim that the entity/individual is affiliated/employed with Raintree Vacation Club**

We strongly urge our Members to use extreme caution when contacted by individuals or companies who make claims that just seem too good to be true. Before doing anything, carefully research the individual or entity involved. Despite having professional-looking salesmen and websites, many of these companies are not legitimate.



## E-STATEMENT ENROLLMENT\*


Continuing in Raintree Vacation Club's efforts to "Go Green", Members now have the option to opt in for Electronic Maintenance Fee statements instead of the paper statements that are mailed to the address on file.

Through the maintenance fee section after logging on to [www.raintreevacationclub.com](http://www.raintreevacationclub.com) with their credentials, Members can opt in to these benefits by following the steps below:




2. In the Options section, select **"E-Statement History"**:

Select the accounts for which you would like to receive E-statements.




